### MINUTES OF THE COUNCIL (PLANNING/GENERAL PURPOSES) MEETING HELD AT BURTON VILLAGE HALL, HIGHBURTON ON THURSDAY, 21<sup>st</sup> JULY 2011 AT 7.30pm

**P1 Apologies and Declarations of Interest**
