MINUTES OF THE PARISH COUNCIL MEETING HELD AT BURTON VILLAGE HALL, HIGHBURTON ON THURSDAY, 6TH FEBRUARY 2014 AT 7.30 pm

Interest**

Cllr R Burton apologised for lateness.

Cllrs R Edmunds, I Lumb and S Triggs were absent.

The following personal interests were declared:

Cllr B Armer in the item on the proposed residential development on Cross Lane, Stocksmoor as he knows people involved in this proposal; Cllr S Dunford declared an interest in Denby Dale and District Rotary Club as she is a member and also in planning application 90028 as she knows the applicant; Cllr J Hirst in planning application 90028 as he knows the applicant and also in planning application 94084 as he was formally involved in the opening of Bar 315; Cllr R Barraclough declared an interest in planning application 94068 as he knows the applicant. He also declared an interest in all the planning applications as he is a member of the Kirklees Heavy Woollen Planning Committee and stated that any views expressed would be of a preliminary nature with the final decision being taken at the Committee meeting when in receipt of full information.

All councillors declared an interest in planning application 90113 as they all know the applicant.

The Chairman of Denby Dale and District Rotary Club addressed the Council on proposed plans to install an Automated External Defibrillator within Kirkburton Parish Council area.

Resolved: To defer the discussion on whether any amendments are needed to the Council's plans. Also to enquire whether it is possible to include the schools outside of the Shelley Pyramid in the Area Committee project and to discuss both issues further when the requested information has been received.

206 Change of Business

Members noted the pre-application consultation and considered submitting a comment. The Clerk advised members that it was inappropriate to submit definite views on the proposal at this stage, as it would prevent a response being made to the formal planning application. It was reported that the residents had been consulted and put forward their views on the proposed development.

207 Proposed Residential Development on Cross Lane, Stockmoor

Resolved: To notify the developer of the residents' views on the development, which were as follows: There would be a loss of open aspect. It would detrimentally impact on the character of the village. It may obscure the fine views from the village to the wider area. There was a concern that the existing sewerage and drainage systems will not support additional houses. In Thunderbridge, there are already regular incidents of sewerage overflowing. There were also concerns regarding highways safety and an impact on natural biodiversity.

The Chairman reported that he had attended Saddleworth Civic Dinner.

212 Plans

The Parish Council objected to this proposed development on the grounds that the site would be over developed, on highways grounds as the access is at the point where the speed limit changes from 50mph to 30mph, there would be over diversification of the site, the proposed development exceeds the existing footprint and there will also be the loss of some mature trees.

Members noted the information from Kirklees and considered agreeing to administer the Area Committee Funding allocated for youth engagement, including settlement of the catering invoice from the Skatepark Opening.

Members noted the consultation being carried out by the Management and Finance Committee into the format of future reports and studied an example of both formats to allow comparison.
