2015/62/91750 *Erection of 12 pen cattery at the rear of 9 Park Side, Flockton.* The Council strongly objected to this proposed development on the grounds that it was a large commercial development out of scale with the size of the plot and in the heart of a residential area.

2015/91943 Demolition of existing petrol station and erection of 4 No retail and residential units (within a Conservation Area) at the former petrol station, North Road, Kirkburton. The Council objected on the grounds of a) inadequate parking, b) dangerous access from the site, c) concerns about the noise level and congestion especially during the construction period. The Council would also request a traffic survey is carried out at the busiest periods of the day before any decision is taken. And if Planning Services are minded to approve the application, it should be on condition that the developer provides an additional zebra crossing.

2015/92156 Discharge of Condition 14 (affordable housing) on previous permission 2014/90460 for outline application for the erection of dwellings at Cross Lane, Stocksmoor. The Council objected to this application.

2015/92293 *Erection of stables to the south of 5 Paul Lane, Flockton.* The Council objected to the proposed development on the grounds that it was detrimental to the visual amenity, being situated in a very prominent position.
