MINUTES OF THE PARISH COUNCIL MEETING HELD AT BURTON VILLAGE HALL, HIGHBURTON ON THURSDAY, 5 SEPTEMBER 2019 AT 7.30pm

Resolved: To permit the Committee to elect co-optees if it wishes.

Members considered electing members to the Working Group.
