Min 103 Chairman's Welcome

Planning Appl 20/93368: *Erection of detached sunroom at 2 Coachgates, Flockton.*

Resolved: To delegate the Clerk to submit a comment when the Flockton members had visited the site.

Planning Appl 20/93498: Work to TPOs 17/95 at the rear of 3 Station Court, Fenay Bridge (Lepton ward). It was noted that no plan had been available on the Kirklees website.
