#### Min LP18 Apologies and Declarations of Interest

**Resolved:** To hold the discussion on Kirkheaton Churchyard in private session, as it concerned contracts and qualified as exempt under the Freedom of Information Act 2000.

## Min LP21 Allotments Rent & Water - Annual Budget 2023-24

Members noted the finance statement dated 28 October and considered the budget for the next financial year.
